Wedding Coordinator will advise you of the total required amount - payable to 'The First Reformed Church'. If the Rehearsal and Wedding do not exceed the below specified time limits, and facilities are left clean & free of damages, the full deposit (or a portion there-of) will be returned after the Wedding Ceremony.

If Rehearsal exceeds 60 minutes, <u>from the scheduled start time of the Rehearsal</u>, the security deposit will be deducted accordingly (as detailed below).

This time limit includes the Wedding Ceremony, Receiving Line, and photo opportunities in our facilities following the Wedding Ceremony. If 90 minutes is exceeded, <u>from the scheduled start time of the Wedding</u>, the security deposit will be deducted accordingly (as detailed below).

Fees for exceeding time limits:

30 minutes over time limit: 50% of the Deposit will be deducted for service provider fees 75% of the Deposit will be deducted for service provider fees 100% of the Deposit will be deducted for service provider fees

Please note – **Payment** of all of the above fees (except Reservation Fee) shall be placed in <u>separate envelopes</u>, attached to the Wedding License, and delivered to the Church Office <u>by the Wednesday before the Wedding.</u>

Non-Refundable Reservation fee is due at the time the Wedding Application is submitted.

If further use of the Church buildings is required in conjunction with the wedding service, please use Form B, (available at the church office) for which rentals and fees are in addition to those listed above. **All fees are subject to change at any time by approval of Consistory.**
